



The Living Well Safeguarding Policy Statement

The Trustees of The Living Well have adopted the safeguarding policies and procedures of the Church of England and the Diocese of Canterbury. These are set out in the Diocese of Canterbury guidelines, 'Safeguarding Children and Vulnerable Adults from Harm'.

In particular we are committed to:

- The safeguarding of all those who come into our care particularly those who are vulnerable
- Carefully selecting and training paid and voluntary staff who might come into contact with those who are vulnerable, using the Disclosure and Barring Service amongst other tools, to check their sustainability
- Responding without delay to every complaint made which suggest that any person may have been harmed
- Co-operating fully with the police, local authority, church authority or any other appropriate statutory body in any investigation
- Ministering appropriately to anyone who has experienced abuse
- Extending pastoral care to those who have offended against children or vulnerable adults whilst ensuring that children and vulnerable adults are protected from them

Here at The Living Well we seek to provide a safe space to all who come, and to treat individuals with respect, dignity and confidentiality.

- We will not disclose that an individual is known to us, or provide any information about that person, except in an instance where we have been told that serious injury or harm will be caused to another individual/or the person themselves; a disclosure of child abuse; knowledge that a miscarriage of justice will occur; that one of our team is summoned by a Court of Law or that terrorist acts have been disclosed.
- In the event of any such circumstances being disclosed we follow the procedures outlined in the Canterbury Diocesan Guidelines, 'Safeguarding Children and Vulnerable Adults from Harm' (a copy is available in the office) and would refer to the Diocesan Safeguarding Team.
